

Continuing Legal Education Requirements by State

Alaska

Every active member of the Alaska Bar Association shall complete at least three credit hours per year of approved Mandatory Ethics CLE. In addition to MECLE, the Alaska Supreme Court and the Association encourage all members to complete at least nine hours of approved Voluntary Continuing Legal Education (VCLE) per year.

Each attorney is responsible for reporting credits earned.

Arizona

The State Bar of Arizona does not approve or accredit CLE providers or individual programs. A total of 15 hours are required, of which three are professional responsibility, every educational year (July-June).

Each attorney is responsible for reporting credits earned.

California

Total hours required every three years: 25 hours. Members must fulfill at least one-half of their MCLE requirement with activities approved for "participatory" MCLE credit. Maximum "self-study" hours: 12.5 hours.

A proportional requirement may be owed because you are a new admittee, have been on Inactive status for a period of time, or have been on Active status but in an Exempt category for a period of time. Additionally, one-half of MCLE required hours must be participatory.

Each attorney is responsible for reporting earned credits online using My State Bar Profile or with an MCLE Compliance Form.

Connecticut

New York

Each attorney shall complete a minimum of 24 credit hours of accredited continuing legal education each biennial reporting cycle in ethics and professionalism, skills, law practice management or areas of professional practice, at least four (4) credit hours of which shall be in ethics and professionalism. Newly admitted attorneys, less than 2 years, have other specific requirements.

Internet On Demand programs are acceptable for experienced attorneys (2 or more years) and newly admitted attorneys based outside of the U.S.

Each attorney is responsible for reporting earned credits to the New York State CLE Board.

Tennessee

Each attorney must complete a total of fifteen (15) hours of CLE, which must consist of no less than twelve (12) General hours and three (3) Ethics/Professionalism hours (or Dual hours) per year. The compliance year runs from January 1 through December 31.

Mediators: Continuing Mediation Education (CME) approvals are routinely sought. Check current Accreditation status for each course. In all cases, each Rule 31 Family Law mediator is responsible for reporting hours earned with a copy of your Certificate of Completion.
